### Meeting Purpose

The Phase 2 Kick-off and Orientation Meeting aimed to accomplish these objectives: Provide Background on SA Tomorrow; Provide an Overview of the Sub-Area Planning Process; Discuss Planning Team Member Roles and Responsibilities; and Provide Planning Team Members Initial Resources to utilize during the planning process.

### Meeting Format

The meeting opened with welcoming remarks by Bridgett White, Planning Department Director, and included a video welcome from Mayor Ron Nirenberg. Chris Ryerson, planning administrator, along with consultants Jay Renkens and Andy Rutz of MIG, Inc., presented on the background of SA Tomorrow, an overview of the Sub-Area Plans intent and topics, a description of community engagement strategies, and the roles and responsibilities of the Planning Teams.

Following the introductory presentation, attendees broke out to Sub-Area Planning Team sessions to further discuss project-specific timelines and upcoming meetings. During the breakout sessions, teams were able to review reading material which included: Planning Team Members roles and responsibilities, basic information and talking points to share with their constituencies, and an informational flyer on each plan's project website, visioning questionnaire, and the first community meeting for their area.

NE Loop 410 and I-35 Planning Team members in attendance for the break-out session included Dr. James Antenen, Karen Bishop, Robert Nolen, Amy Putney, and David Rittenhouse. Planning Team members discussed general days and times they are available for future Planning Team meetings. In general, Thursday mornings and evenings and Friday mornings appear to be options for most of the group.
